

## Taranaki Home & Lifestyle Expo 2019 Voucher Competition

### Terms and Conditions

1. Entry to the competition constitutes acceptance of these terms and conditions.
  2. Attendees of the Taranaki Home & Lifestyle Expo 2019 are invited to submit their email address at the tablets located in the foyer at the Taranaki Home & Lifestyle Expo 2019. A survey link will then follow to the email address provided and to enter the competition draw, each entrant must complete the survey.
  3. The competition opens on Friday 12 April 2019 at 10.00am and closes on Sunday 14 April 2019 at 4.00pm (**Promotional Period**). Entries received after the Promotional Period will not be eligible to win the prize. The winner will be drawn after the competition closes at 4.00pm on Sunday 14 April 2019 (**Closing Date**).
  4. The prize shall comprise of a \$1,000 Resene voucher (**Prize**) which must be redeemed at the winner's local Resene owned ColorShop.
  5. Entry is open to anyone who attends the Taranaki Home & Lifestyle Expo 2019 and completes the survey before the Closing Date. Employees of the New Plymouth District Council (**the Promoter**) and Exhibitors at the Taranaki Home & Lifestyle Expo and any businesses associated with the Prize (Resene) and their immediate families are ineligible to enter.
  6. Each entry which is submitted correctly during the Promotional Period will be entered into the competition draw.
  7. The Promoter will determine which entrant wins the competition. The Promoters' decision is final and no correspondence will be entered into.
  8. Only one entry per person is allowed.
  9. The Promoter will notify the winners by telephone within 7 days of the Closing Date. The winner's name will be published on the Taranaki Home & Lifestyle Expo website (<http://www.homeandlifestyleexpo.co.nz/>) once the winner has been notified. If the Promoter is unable to make contact with the winner after 3 attempts, the Promoter will be entitled to re-draw the Prize.
  10. The Prize cannot be transferred, exchanged or redeemed for cash.
  11. The Prize is valid only at the winner's local Resene ColorShop. The Promoter will issue the Prize in the form of a letter to the winner which can be used multiple times until spent. The Prize must be redeemed in full by 31 December 2019 and is valid only for purchases of Resene paint, wallpaper and decorating accessories at the normal recommended retail price.

As the Prize is to be supplied by an entity outside the Promoter's control should that entity fail, for whatever reason, to supply the Prize, the Promoter has no responsibility for the provision of the Prize and is not obliged to provide an alternative prize or take legal action to require the prize supplier to provide the Prize.
