

# Taranaki Home & Lifestyle Expo 2019 Prize Pack Competition

## Terms and Conditions

1. Entry to the competition constitutes acceptance of these terms and conditions.
  2. The competition opens when ticket sales commence for the Taranaki Home & Lifestyle Expo 2019 and closes on Thursday 11 April 2019 at 12 noon (**Promotional Period**). Entries received after the Promotional Period will not be eligible to win the prize. The winner will be drawn after the competition closes on Thursday 11th April 2019 (**Closing Date**).
  3. Pre-event ticket purchasers of the Taranaki Home & Lifestyle Expo 2019 are automatically entered into the draw to win the Taranaki Home & Lifestyle Expo 2019 Prize Pack. To be eligible for the prize draw:
    - (a) ticket(s) to the Taranaki Home & Lifestyle Expo 2019 must be pre-purchased from Ticketek before the Closing Date; and
    - (b) the ticket purchaser must provide his/her name, contact number and email when purchasing the ticket(s).

  5. Employees of the New Plymouth District Council (**the Promoter**) directly involved with the Taranaki Home & Lifestyle Expo 2019, exhibitors at the Taranaki Home & Lifestyle Expo and any businesses associated with the Prize and their immediate families are ineligible to enter.
  6. The Promoter will determine which entrant wins the competition. The Promoters' decision is final and no correspondence will be entered into.
  7. One entry per ticket purchased is allowed.

8. The Promoter will attempt to notify the winner at the time of Prize draw on the Closing Date. If contact cannot be made, the Promoter will notify the winner by telephone within 7 days of the Closing Date. The winner's name will be published on the Taranaki Home & Lifestyle Expo website (<http://www.homeandlifestyleexpo.co.nz/>) and Facebook event page once the winner has been notified. If the Promoter is unable to make contact with the winner after 7 days, the Promoter will be entitled to re-draw the Prize.
9. The Prize cannot be transferred, exchanged or redeemed for cash.
10. In addition to these terms and conditions, each business associated with the Prize (identified in Clause 4 above) may have its own terms and conditions that must be agreed to by the winner prior to collecting the Prize.

As the Prize is to be supplied by entities outside the Promoter's control should that entity fail, for whatever reason, to supply the Prize, the Promoter has no responsibility for the provision of the Prize and is not obliged to provide an alternative prize or take legal action to require the prize supplier(s) to provide the Prize.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity and age) and to disqualify any entrant who submits an entry that is not in accordance with these terms and conditions. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If an entrant is under the age of 18 years they acknowledge that they have their parent/legal guardian's permission to enter the competition and that if they are drawn as a winner that their parent or legal guardian will be awarded the Prize, and that their parent or legal guardian will be required to sign acceptance of the terms and conditions of entry prior to claiming the Prize.

Entrants may receive email notifications from time to time and can unsubscribe at any time. The Taranaki Home & Lifestyle Expo Marketing Database will only be available to Exhibitors contributing over the value of \$1,000 to the Taranaki Home & Lifestyle Voucher Competition or the Taranaki Home & Lifestyle Expo Prize Pack.
